Grant Awarding Policy
Lakeland 100 Coniston Community Fund

Objective: - the aim of the Lakeland 100 Coniston Community Fund is to be of social benefit for children or the wider community

Eligibility – the grant must be spent on a specific item to benefit the local community and evidence will be required of item(s) purchased. The money cannot be used towards to pay salaries or support profit making.

Who Can Apply

Groups that can apply:-

- Charities, voluntary or community organisations that are not-for-profit and
- Are able to demonstrate any funding will directly benefit residents or enhance the environment within the Parish of Coniston

Individuals, businesses and political parties are NOT eligible.

Conditions

- Normally only one application per group within a 12 month period will be considered.
- Coniston Amenities Fund reserves the right to reclaim any grant not used for the purpose specified on the application form.
- Retrospective funding cannot be given.
- Acknowledgement on receipt of a grant cheque is required.

Application Process

- Applications should be made by completing the Grant Awarding Application Form (available from the Clerk) with a copy of the latest accounts or balance sheet.
- Applications should be sent to the Clerk by 31st December and will be discussed at the January Coniston Amenities Fund meeting. Applications will then be sent to Lakeland 100 for approval.
- Applicants will be informed of the decision and if successful invited to attend an Award Ceremony.
