126/2021	<p>Public Participation</p> <p><u>County Councillor</u></p> <p>Councillor Brereton reported on a number of issues:</p> <ul style="list-style-type: none"> • Long-term highway issues continue to be pursued; Councillor Brereton is hoping to secure either Zoom call meeting, or a site visit to move things forward across a range of Highways issues both in Coniston and in neighbouring parishes. • B4RN is producing a digital leaflet for distribution and widely available online. The aim of this is to publicise the scheme, its benefits and to generate interest. <p><u>District Councillors</u></p> <p>Councillor Coward described how South Lakeland District Council had automatically distributed grants to those whose eligibility had previously been</p>	

established; she encouraged everyone who feels that they are 'falling between the cracks' to apply for the District Council's discretionary grants.

Greening Campaign. It is hoped to create a group locally, which can promote small changes to create climate change.

Elections are being held on the 7th May 2021. The clerk had attended a briefing and parish councillors were asked to consider whether they would be standing at the next election.

Councillor Wharton outlined how agencies are working together to address the issues which will be presented after the lifting of Lockdown.

He reported that the purchase of the Farmers' Arms by Grizedale Arts is progressing well.

Cumbria Constabulary

PCSO D Ross reported that for the period 16th January and 15th February 2021 there had been 11 incidents of particular note in the Coniston area.

These are as follows:

- 1 crime of theft of boating equipment
- 1 (damage only) road traffic collision
- 1 suspicious incident: no trace on police arrival
- 1 concern for welfare resulting in Mountain Rescue
- 7 possible breaches of covid regulations reported

Coniston Business Forum

Mr Rutland reported via email that the next Business Forum meeting had not been arranged.

National Trust

Mr Moffat reported that:

- No properties are empty or due to fall empty.
- Rangers are busy tree and hedge planting in response to larch and ash disease which has changed the landscape.
- Staffing reviews had been implemented, this places natural limits on what might be achieved, however, focus will be on visitor management working in conjunction with other agencies.
- The Gondola, Gallery in Hawkshead and Hilltop in Sawrey all have plans to enable them to open throughout the season.
- Outdoor facilities such as Glen Mary and Tarn Hows will remain open, but will be regularly monitored.
- Last year there was a considerable change in the nature and behaviour of the visitors to the area. In 2020 agencies worked well together to respond to this challenge, however, in preparation for 2021 the National Trust has been working closely with other key agencies to ensure that a robust plan is developed to enable them to manage problems more pro-actively.

	<p><u>Lake District National Park</u></p> <p>Mr Hill was not able to attend; however, he reported that he had reported the Lake Road Bridge to Cumbria County Council before Christmas.</p> <p>Ms S Spicer indicated that work is scheduled to repair and improve the footpath between High Waterhead and the village, but was unable to identify a date by which that will be completed. She also invited the Parish Council to nominate one person to sit on the Tilberthwaite Partnership management group.</p> <p><u>Councillors attending the Institute Committee meeting</u></p> <p>Councillor Hall reported that:</p> <ul style="list-style-type: none"> • the Museum and Institute remain closed • events have been planned to commemorate what would have been Donald Campbell's 100th birthday • Discussions regarding Bluebird remain ongoing • Helen Glaister is taking early retirement. The Parish Council were unanimous in their appreciation for the work Helen had led over many years service promoting the Institute, the Museum, music events and events important to village life. The shortfall will be £179 (total cost £575 less £396 insurance) • The new waste bin on Hawkshead Road (B5285) has been installed. • During the summer months, the existing arrangements are to be reviewed including communication, areas to be gritted, sourcing supplies etc. • Lake Road Bridge remains in a state of disrepair.
